Some one hundred National Guardsmen took part in the ROTC Parade.

General Blanding attended the East Florida Seminary, (Present University of Florida), and graduated as Cadet First Lieutenant in 1894.

He served as an enlisted man in the Gainesville Guards, Florida State Troops, from 1895 until the unit was disbanded. In 1899, he was commissioned a Captain in the National Guard of Florida. Promoted to Major in 1906, Lt. Col. in 1908, Col. in 1909, He was commanding Officer of the Second Florida Infantry in Mexican Border Service from June, 1916-March, 1917.

He entered the Federal Service in 1917 and was appointed a Brigadier General by the President on August 30, 1917. Going overseas in command of the 186th Infantry Brigade, 93rd Provisional Division, in April, 1918, he was at the front three days after his arrival in France. General Blanding remained in France throughout the war and was discharged in March, 1919. He was awarded the Distinguished Service Medal.

In 1936, President Franklin D. Roosevelt appointed General Blanding Chief of the War Department's National Guard Bureau.

General Blanding was born at Lyons, Iowa, but his family moved to a farm near Gainesville, Florida, when he was two years old.

In 1908, he married Miss Mildred Hale, a native of Georgia, who was then living at Bartow, Florida.

When he was discharged from the regular Army after WWI, General Blanding accepted a position with the Consolidated Naval Stores Co. In 1922, he resigned to become an executive in the Florida Citrus Exchange. He retired in 1933.

Camp Blanding is named in his honor.
